#### Receiving

- Must report all deficiencies to the Vendor and the Warehouse Supervisor and must resolve any discrepancies in a timely manner

#### Issuing

- Responsible for the issuing of all inventory Ensure accuracy of all issue transactions
- Enter all issue transactions into SAP in a timely manner to ensure an accurate and efficient replenishment of inventory

Pull materials from stock locations and prepare items for internal shipping

## Shipping

- Responsible for the preparation of all documentation, (Company, legislated or carrier) for the shipping of goods off site
- Must ensure all materials being shipped off site are packaged or skidded for safe transportation
- Must ensure all WHIMIS and TDG (documentation and labelling) requirements are met when applicable materials are being shipped offsite. Stocking\
